

### **Outside Malaysia**

#### S&P 500 little changed for second day amid stronger factory data

US stocks were little changed, as stronger American factory data contrasted evidence of sluggish global growth while investors braced for the possibility of higher interest rates by this summer. The S&P 500 rose 0.1% to 2,099.33. The Dow added 2.47 points to 17,789.67.

#### US economy grows modestly as job market tightens, Fed says

The US economy expanded at a modest pace across most of the country since mid-April, causing the labor market to tighten as employers continued adding jobs and nudging wages higher, a fed's report showed. "Employment grew modestly since the last report, but tight labor markets were widely noted," according to the Fed's latest Beige Book,. "Wages grew modestly, and price pressures grew slightly in most districts."

#### Manufacturing unexpectedly accelerates amid US growth signs

Signs of better US growth are cropping up, including in manufacturing, which has been a laggard of the economy. Activity at factories unexpectedly expanded at a faster pace in May, helped by an increase in orders, the Institute for Supply Management reported. The group's index climbed to 51.3 from 50.8 in April, while the median forecast in a Bloomberg survey of 81 economists called for 50.3.

#### Euro area manufacturing near stagnation signals slowdown ahead

Manufacturing in the 19-nation euro area barely grew in May, damping confidence in the strength of the region's economic recovery, according to Markit Economics. A Purchasing Managers Index slipped to 51.5 from 51.7, the company said, in line with a May 23 estimate.

#### OECD cuts UK economic forecast as Brexit warnings renewed

The Organization for Economic Cooperation and Development (OECD) cut its UK growth forecast and repeated its warnings about the economic damage a vote to leave the European Union would cause. The group said that uncertainty surrounding the June 23 referendum has already undermined growth and cut its 2016 forecast to 1.7% from 2.1%.

#### Australia economy grows most in four years thanks to exports

Australia's economy grew at the fastest pace in four years last quarter, underpinned by an export bonanza, even as diminishing inflation pressures spurred the central bank to cut interest rates in May. Gross domestic product rose 1.1% qoq in 1Q16 (0.7% in 4Q15), and beat economists' estimates for 0.8% increase. Expansion was driven by a 4.4% jump in exports, which added 1 percentage point to growth; and a 0.7% increase in household spending.

#### China factory gauge signals further economic stabilization

China's official factory gauge for a third month remained above the dividing line that signals improving conditions, adding to recent evidence of stabilization in the world's second-largest economy. The manufacturing purchasing managers index stood at 50.1 in May, the nation's statistics agency said, higher than the median estimate of 50 in a Bloomberg survey.

#### Crude oil closes near US\$49 as OPEC seen discussing output ceiling

WTI closed near US\$49 a barrel as OPEC delegates said the group would be discussing the reintroduction of output ceilings at meeting in Vienna. Brent for August settlement dropped US\$0.17 to US\$49.72 a barrel.
